#### Notices for Visitor Visa Extension

- The period of stay is calculated starting from the next day of arrival.
- The foreigner with landing visa or visaexemption entry cannot apply for extension.
- For granted purposes, foreigner may apply for visa extension within 15 days before the date of expiration.

# Application for Alien Resident Certificates

#### • Required documents:

- A. One color photo in 2-inch (background color in white)
- B. Original & photocopy of applicant's passport (originals will be returned after verification).
- c. Related documents: ex. For Student: Student identification card or certificate of enrollment is required. (First timer may submit the school admission).
- Processing time: Within 10 working days.
- Fees: One year term: NT\$1,000.

Two year term: NT\$2,000.

Three year term: NT\$3,000.



#### **Photo Font**



A thin half-length color photo with a glossy finish taken with a white background within the last six months that should be 4.5cm X 3.5cm with an image of the head that should not be shorter than 3.2cm or longer than 3.6cm from the top of the head to the chin, without wearing a hat or a pair of color glasses, with clear facial features not covered and identifiable, and should not be modified or composed.

#### Notices for Alien Resident Certificate

Foreigner holding resident visa shall apply for an Alien Resident Certificate at NIA local Service Center within 15 days. Lost, stolen or damaged ARC will be charged NY\$ 500 to reissue at holder's expense.

# Application for Lost Passport Declaration

#### »Required documents:

- 1. Personal identification document.
- 2. Two colored photos in 2 inch (Background color in white)

#### **Notices:**

The applicant is required to complete the process in person. Foreigner who overstayed less than 3 months may either pay the penalty at NIA local Service Center, or directly pay the penalty at airport/harbor Border Affairs Brigades.

Overstayed foreigner may be prohibited from re-entry

# **Application for Overstay Exit**

#### Required documents:

- A.Passport or travel document.
- B.Booked flight/ferry ticket for departure within seven days.

#### • Penalties:

- $\circ$  Overstay for 1 10 days, fine of NT\$2,000.
- $\circ$  Overstay for 11 30 days, fine of NT\$4,000.
- $\circ$  Overstay for 31 60 days, fine of NT\$6,000.
- Overstay for 61 90 days, fine of NT\$8,000.
- Overstaying more than 90 days, fine of NT\$10,000.
- Foreigner under 14 may exempt from penalty.
- Foreigner aged between 14 to 18 pays halve the penalty

Foreigner overstayed under 30 days may re-apply an ARC after paying the penalty if the granted purpose of residency still exist.

# **Notices for Overstay Exit**

Need to complete the process in person.

• Foreigner who overstayed less than 3 months may either pay the penalty at NIA local Service Center, or directly pay the penalty at the Border Affairs Brigades.

Overstayed foreigner in Taiwan may be prohibited from reentry.

# Penalties for Violations of the Immigration Act

Foreigner is required to carry passport, Alien Resident Certificate or Permanent resident Certificate at all time. The fine will be NT\$1,000 when failed to do so.

>>> Foreigner failed to apply for ARC within the specified period (15 days).

A.First time-fine:NT\$2,000

B.Second-fine:NT\$5,000

C.Third-fine:NT\$1,0000

Foreigner is require to update address on ARC within 15 days when acquiring new residence. Penalty will be received as following order when failing to do so.

A.First time-fine:NT\$2,000
